(b) Application dated 4-4-62 received from Captain M.S. Saniya, Transport Officer, C & B, Dacca requesting grant of plot No. 16 B measuring 1/8 acre on payment of Rs. 1,000/- as premium. The petitioner has taken keen interest for the development of bazaar area and helped the Board in supplying the machineries etc. at the disposal of the Board.

(c) Application dated 4-4-62 received from Mrs. Nurul Islam Barni M.A. /c Mr. Osman Shahi Khan M.A., Controller of Mill, Fazla requesting grant of a piece of land measuring 4 acres or two plots of 1/8 acre on payment of reserved price.

(d) Application dated 4-4-62 received from Dr. Bazlur Ali, M.Sc. Plant Pathologist, Department of Plant Protection, Dacca requesting grant of piece of land measuring 1/4 acre for residential purposes on payment of reserved price.

7. To consider the payment of Rs. 12,000/- being the balance amount of the cost of one tractor and trailer to P/S Far Farot, etc. The Ministry of Defence vide their letter No. 18/10/17/100 dated 20-1-62 sanctioned Rs. 12,000/- for the purchase on the same which amount has already been paid.
