

PROCEEDINGS OF THE MEETING OF CANTONMENT BOARD, DACCA CANTONMENT
HELD ON 31ST DECEMBER, 1960 AT 1000 HOURS IN CONFERENCE ROOM

1. To note statement of monthly account for the month of November, 1960, compiled in accordance with Rule 90 of the Pakistan Cantonment Account Code, 1955.

RESOLUTION : - Noted and approved.

2. To read Sanitary Report on Dacca Cantonment for the month of November, 1960.

RESOLUTION : Read and noted. The Cantonment Board resolves on the following sanitary and administrative measures which should be initiated and implemented :-

- (a) A proper Bus Stand should be provided near the Cantt. Market. The Cantonment Executive Officer should be required to submit an estimate of the project and thereafter requisite sanction of the Ministry of Defence be obtained to incur expenditure from the Closing Balance for the current financial year.
- (b) The Provincial PWD should be called upon to level the berms of the road without any loss of time as at the moment these berms are so uneven as to constitute a source of danger to the pedestrians at night. The Provincial PWD may also be informed that the G.O.C. is very keen to see the improvement to the berms of this road passing through Cantonment area. It was also noticed that the road requires repairs at a number of places.
- (c) Large scale unauthorised grazing in the Cantonment area has become a nuisance, and therefore, the Cantt. Board after due deliberation has decided that the District Magistrate, Dacca may immediately be approached to impose Section 144 Criminal Procedure Code in the Cantonment area prohibiting grazing of cattle in all public places through out the Cantonment unless a valid pass from the Cantonment Executive Officer has been obtained for the purpose. All owners of the cattle found to be contravening this order should be chaled by the police or the Cantonment Board as the case may be and the District Magistrate may also be requested to direct the Magistrate concerned to impose deterrent fines upon the offenders.

- (d) PIE dogs have become another source of nuisance in the Cantonment area. The Station Commander may please be requested to find a dog shooter for the Cantonment Board from the ex-soldiers, as so far all efforts to recruit one have proved abortive.
- (e) An estimate for improvement to the Cantonment market as required by the sanitary authorities should be prepared by the Cantonment Overseer immediately and should be placed for consideration of the Board at its next meeting.
- (f) The G.E. (maintenance) should be asked to ensure copious water supply to the Cantonment School. In future points concerning the G.E. in sanitary report should be forwarded to him in the form of an Extract and his observation be obtained for the information of the Board.
- (g) It was brought to the notice of the Board that thefts in the Cantonment area/on the increase. The matter should be taken up with the Station Headquarters and the Supdt. of Police for tightening up security arrangements and identification and registration of private servants in the Cantonment area should be taken in hand by the police.

3. Reference Cantonment Board Resolution No. 15 dated 26-11-60.

To consider representation submitted by M/S E.I. Industries agreeing with the decision of the Board and requesting grant of an alternative permanent site for shifting of the Industry to an area near Mohakhali village under control of Cantonment Board.

RESOLUTION : The Cantonment Board dispassionately considered all aspects of the case and resolved that the existence of the Industry on this site cannot be countenanced. This is absolutely final. The Industry must be shifted to proposed Saddar Bazar area and shifting in all its aspects must be completed by the 15th of February 1961. The Board, has therefore, decided upon the following measures :-

- (a) As a temporary expedient a temporary licence should be granted to the Industry on the proposed new site and the shifting should commence forthwith.
- (b) As a long term measure an area measuring one acre should be given to the Industry on lease on payment of Rs.10,000/- as premium and Rs.3,000/- annual rent. Necessary sanction of Central Government in the Ministry of Defence should be obtained therefor.

4. To consider Station Headquarters letter No. 201/7/X/Q dated 20-12-60 regarding payment of rent etc. in respect of Unit Line Primary School to Government.


RESOLUTION : As there was a definite understanding at the time of transfer of the School to the Board that NO rent will be payable, the Cantonment Board does NOT agree to the payment of the rent now demanded. However, it should be suggested to the Station Headquarters that as the transfer to the Cantonment Board of this army property was free of rent, they should obtain necessary sanction of the C.F.A. to this measure, so that, the matter may be settled for all times to come.


5. To consider C.E.O's note dated 28-12-60 requesting sanction of the Board to provide Uniforms to Class IV employees, in accordance with the principle laid down in Ministry of Defence letter No. 57475/III/81/D-5/LCH dated 15-7-55. The total expenditure involve Rs.1,500/- including cost of material and stitching charges.

RESOLUTION : Approved. as regards outdoor staff.

6. To consider C.E.O's note dated 28-12-60 requesting creation of a post of a Peon for C.E.O.
