RESOLUTION:

- (a) The plan sanctioned under C.B. Resolution No.3 dated 16.6.1962 subject to the directions as endorsed on the plan to be strictly adhered to.
- (b) Reasons given by the lessee for not completing the building within the stipulated time are considered unreasonable.
- (c) In any case, the time given to the lessee vide notice issued to him under Sub- clause (5) of Clause (1) of the lease read with Sections 114 and 114A of the Transfer of Property Act 1882, expired on 28.2.66.
- (d) In view of the above the lessee should be issued a notice Under Section 185 of the Cantt Act, 1924 to stop the erection of the Building forthwith as the said erection is illegal under Section 184 IBID.
- (e) Action be expedited for determination of the lease as per para 3 of the notice as mentioned in (d) above. The case, along with other similar cases, has been sent to Ministry of Defence for final decision. The Ministry of Defence be requested by signal to expedite the decision.
