Out of 117 Residential Plots allotted, 54 Nos have been built up and occupied, and out of these only 26 numbers are actually residing in the Cantonment. So the constitution of the Board does not require any change as far as this aspect is concerned. The Lessees Association is not recognised by the Board and as such the DDML&C also be requested not to recognise it.

- (c) Proposed Bye-laws for regulating the seizure and confiscation of ownerless animals straying within the limits of Dacca Cantonment framed under clause (6) of Section 282 of read with Section 283 of the Cantts Act, 1924 based on those framed by Quetta Cantt, incorporating the proposed Revised Rates for impounded Cattle.

- Station Commander will also submit his recommendations on the procedures to be adopted for liability of contracts for development work. Pending this the CCO will not give any contracts or M.E's payments to the Contractors without:-
- a. obtaining technical advice/report in writing from the M.E.
 - b. without prior approval of the Station Commander.

15. CANTT MODERN SCHOOL:

To consider & approve the transfer of Rs.75,000/- from the Cantt Fund, to the Standard Bank as a one month's Special Time Deposit. This amount has been provided in the Budget Estimates 65/66 for the following projects of Cantt Modern School:-
