Board should provide accommodation to this staff at 10% ment of their pay. The Board has already taken over some bashas for the trasferable category as well as for others and these are given at 10% to the servant concerned. The balance will be paid by the Board. The Government be informed accordingly. that areas Item No. 39 - About developing of business projects like dairies, agricultureal farms etc.

The Board is of the view that such projects are premature for this Cantonment. Item No. 43- The view of the Board are that the present sections are

quite adequate. No amendment to sections 175 and 176

is considered desirable.

Item No. 44The views of the Board on the question of conferring powers to the Cantonment Executive Officers under section 179 of the Cantonments Act, 1924(II of 1924) are that, if any power can be given, they can only be in the bazar area. They will automatically carry with them the land provisions of sub-division of sites, change of purpose, which are at present with the Bazar Committee formed under section 43-A of the Cantonments Act, 1924. The question of giving any powers in the bungalow area under the M.E.O., does not arise at all.

The present ix system is a good one, and though it delays the building applications to some extent, but this system is sound, because the administration is given ample time to investigate taxthe into the building applications. If this power is given to the Cantonment Executive Officer it is possible that the pressure of applicants may reduce the time of investigation and may not be able to produce the results desired.

It is, therefore, recommended that the powers should remain with the bazar committee subject to the confiremation the Board, and no power to the Cantt. Executive Officer be granted about building applications, because it is not considered desireable in the public interest.

Item No. 62 & 63 - About the building bye-laws and reservation of of seats in the T.B. Hospital.

Noted for compliance. The Board is of the view, that when the Cantonment is developed; two seats in the Provincial Government Hospital, be reserved for Cantonment Residents.

- Item No. 66 Inclusion of Railway Station in Cantonment limits.

  The Railway Station is already a part of Cantonment of Dacca. The matter should be taken up with the Railway Authority to direct their hawker's to obtain licences from the Cantonment Board.
  - (ii) The Survey of Cantonments in East Pakistan is being done by Survey of Pakistan and the M.E.O. is giving all the assistant possible.
- Item No. 6 Payments to the Boards of 50% of the premium realised from areas disposed off by the M.E.O. The Cantt.

  Board of Dacca is vitally interested in the development of the Community Centre and the SADDAR BAZAR Dacca Cantonent. The Board is of the view, that for the development of Sadar Bazar, the Central Government should come forward with a grantin aid for the roads and other services.
  - (ii) As for the Community Centre, it is recommended that the MES should make all the roads and demarkate the areas by pillars, so that, the MEO can auction the plots. In that no contribution to the Board is necessary.
    - (iii) If 50% of premium is paid to the Board and the buildings of roads is to be made the responsibility of the Board, then an advance grant will be required, no premium can be fetched without roads.
- Item No. 24 About the Electoral Rolls of the Army personnel for election.

Noted for future guidance.

- Item No. 26 The President (G.C.C 14 Div) of the Cantonment Board, is of the view, that the quarterly inspections of the Cantonments by the M.E.O. are entirely useful to the military authorities; for the M.E.O. keeps the Commander in touch about the development of each Cantonment. He also renders necessary advice to the Cantonment Executive Officer, about Cantonment matters, the importance can not be over imphasised.
  - (ii) The M.E.O. is empowered to inspect under Section 47 of the Cantonments Act, 1924, and under that section any officer can be appointed to inspect the Cantts. The present need of the inspection, is all the more necessary as young officers are running most of the Cantonments.

- 10. To approve the Annual Consolidated Account for the year 1955-56, Dacca Cantonment.
  - RESOLUTION: The annual consolidated account as placed on the table is approved, and should be forwarded to the authorities concerned.

11. To consider the Military Conservancy agreement for the period of one year from 1st April 1956 to 31st March 1957.

RESOLUTION: The agreement as parced on the table is approved. The total amount of the agreement is Rs. 43,488/-/- per annum or Rs. 362/- per month.
