

PROCEEDINGS OF THE CANTONMENT BOARD, DACCA CANTONMENT FOR THE PERIOD
31ST JANUARY 1958, HELD ON 25TH FEBRUARY 1958 IN THE CANTONMENT BOARD
OFFICE AT 0900 HOURS.

Before proceeding with the items of agenda, Major Aurangzeb, Garrison Engineer took the oath of allegiance as required under Section 18(1) of the Cantonments Act, 1924 (II of 1924).

1. To read the monthly statement of accounts of receipts and expenditure for the period ending 31st January 1958.

RESOLUTION : Read. Income and expenditure in respect of Cantonment Modern School may also be shown separately for facility of reference.

2. To consider Cantonment Executive Officer's note recommending fixation of progressive scale of pay of sweepers - malies and chowkidars employed by the Board.

RESOLUTION : Considered. The scale of pay of sweepers, malies, chowkidars is recommended to be fixed at Rs. 28- $\frac{1}{2}$ -32.

3. Reference Cantonment Board Resolution No. 9 dated 28-11-57. To consider letter No. DEV/BR-49/617/842 dated 27th January 1958, received from Chief Manager, National Bank of Pakistan, Dacca proposing certain additions and alterations in the old station Canteen building for the establishment of a branch of the bank.

The estimated cost of renovation as provided by the Garrison Engineer is Rs 12,751/4/-

RESOLUTION. Approved. The Garrison Engineer be asked to undertake renovation to the building at an early date.

4. Reference Cantonment Board Resolution No.10 dated 28-11-57. To consider the detailed account of expenditure incurred on the School Bus body building at PEME Workshop.

RESOLUTION. Considered. Expenditure of Rs 10,000/- as intimated by PEME Workshop as cost of body building of School Bus is approved subject to any variations which may be communicated by O.C. PEME Workshop. Necessary sanction for expenditure may be obtained from the Ministry of Defence.

5. To consider quotations received for the supply of furniture for Cantonment Modern School. The quotations of M/S MODERN FURNISERS are the lowest. The firm are also MES suppliers as recommended by ~~MEMO~~ C.S.O.

RESOLUTION. Considered. The lowest ~~xi~~ quotation of
M/S MODERN FURNISHERS is approved.

6. To consider Government of Pakistan Ministry of Defence letter No.11/3/G/2-K/57-58/D-5/51., dated 13-1-58, sanctioning a Special Grant-in-Aid of Rs 14,000/- for the establishment of a Dispensary in Dacca Cantonment.

RESOLUTION. Noted. The details may be worked out by S E M O.

7. To consider increase in the number of teachers from 7 to 11 in Cantonment Modern School in view of increased admissions in the School.

RESOLUTION. Approved. Necessary proposals along with statement of proposition be forwarded to the Ministry of Defence for sanction.

8. To consider Ministry of Defence letter No.143/1/G/D-5/58 dated 11-2-58, regarding centralisation of certain categories of teachers in Cantonment Board Schools.

RESOLUTION. The proposal of centralisation of certain categories of teachers is NOT considered practicable in case of East Pakistan.

9. To consider MEO East Pakistan Circle letter No.EPC/230/77 dated 11-2-58 proposing transfer of 5-23 acres of land (Survey No.68) to Class "C" for the purpose of Non-Muslim Burial ground.

RESOLUTION. The proposal may be returned to the M E O for reconsideration on the basis of actual requirement.

10. To consider the report of the Cantonment Executive Officer as to the sufficiency of the Security deposit of the persons handling cash or holding stores vide Rule 42(b) of the Pakistan Cantonment Account Code 1955.

RESOLUTION. Noted.

11. To consider employment of Two Bhisties for a period of one month from 5-2-58 for sprinkling of water on road-sides at Staff Road/Tiger Road which are being widened.

RESOLUTION. Considered. The employment of two Bhisties at fixed pay of Rs 54/- p.m is considered essential for a period of 3 months. Necessary sanction from the Ministry of Defence be obtained.

12. To consider that the construction of 4 additional rooms for Cantonment Modern School has NOT yet been undertaken by the MES. The present number of students on roll in all classes (11 Sections) is 216. The present School building has only 6 class rooms and there is NO accomodation available in the School premises. The HANGER has already been declared "Dangerous" by MES.

RESOLUTION.

The case was thoroughly discussed by the Board. After considering all the aspects of the case and in the interest of Education and the best use of ~~the~~ Cantonment Board building, it was decided that 5 classes should be shifted immediately to the present Cantonment Board Office building.

The Cantonment Board Office should move to one of the Bhashas on School Road adjacent to the present MEO's Office.
