3. To consider application dated 30-8-57 submitted by M/S Choudhury, Cantonment Board Conservancy requirement supplier, requesting refund of his security money amounting to Rs. 200/-.

RESOLUTION: The security money amounting to Rs. 200/- may be refunded.

4. To consider Executive Engineer, Central Div. No. III, Pak. PWD, Dacca's letter No. W-4/2 dated 25th July 1957 forwarding for approval a detailed estimates for annual repairs to Cantonment Board Office amounting to Rs. 3,050/-. If approved, the amount shall have to be provided for in the Budget Estimates for the year 1957-58.

RESOLUTION: Approved. The amount be provided in the Budget Estimates for the year 1957-58.

5. To consider Executive Engineer, Central Div. No. III, Pak. PWD, Dacca's letter No. W-4/4 dated 30th July 1957 forwarding for administrative approval an estimate amounting to Rs. 3,415/-including departmental charges, on account of repairs to the thatched common room in the compound of Cantonment Board Board Modern School.

RESOLUTION: The thatched common room will NOT form part of permanent Cantonment School Building and therefore absolute minimum amount should be spent on the building to make it habitable. The estimate is very high and be returned to Pak. PWD for forwarding a revised estimate embodying only essential minimum repairs.

6. To consider Executive Engineer, Central Div. No. III, Pak. PWD, Dacca's letter No. W-4/9 dated 31st July 1957 forwarding for administrative approval an estimate amounting to Rs. 2,680/-including departmental charges, framed to meet the cost of repairs to Canteen situated within the compound of Cantonment Modern

RESOLUTION: The old Canteen building, since purchased by the Cantonment Board, needs thorough repairs and renovation including electrification etc., to make it into class rooms. The estimates to be returned to Pak. PWD for re-submission accordingly.

The bye-laws framed for the regulation or prohibition of Traffic in streets in the Dacca Cantonment, framed by the Cantonment Board, Dacca, in exercise of the powers conferred by clause (4) of section 282 read with section 283 of the Cantonments Act, 1924 (II of 1924) were notified for inviting objections/suggestions.

RESOLUTION: No suggestions/objections have been received, the bye-laws be forwarded to the Ministry of Defence for approval and publication in Gazette of Pakistan.

8. To consider M.E.O., East Pakistan Circle, Pacca Cantonment's letter No. EPC/A/303/48 dated 10th September 1957, regarding provision of a children park in Pacca Cantonment.

RESOLUTION: Considered. Necessary proposal for the transfer of land in question to class "C" be submitted to the Ministry of Defence through the M.E.O., East Pakistan Circle, Pacca Cantonment.

9. To consider provision of Modern fluorescent lights in Dacca Cantonment.

RESOLUTION: Considered and discussed. The existing tube lights are NOT sufficient and are also NOT considered satisfactory. Garrison Engineer may be asked to forward details of requirements together with an estimate, so that provision for expenditure be made for sanction by Ministry of Defence.
