12. To consider GSO II (Edn) HQ 14 Div. letter No. 201/16/Edn dated 18-1-61 intimating that Mr. Thornhill selected for appointment as Principal, Adamjee School is sailing from England on 11-2-61. The probable date of his arrival will be intimated later.

RESOLUTION: Noted. The scale of pay will be the same as for the previous Principal Mr. G.A. Dolman.

15. To consider Government of Pakistan, Ministry of Defence letter No. 7/M/580/L/D-5/LCH dated 29th December, 1960, returning the case of grant of land to M/S K.S.B. Pumps Company Limited in proposed Sadar Bazar area unsanctioned subject to following observations:-

- (i) Board's views whether a commercial concern of this nature will be any way beneficial to the Sadar Bazar even though the Notification of the proposed Sadar Bazar is not through.
- (ii) The premium should be concurred in by collector and should be based on the average of sales that may have taken place in the Locality.
- (iii) The area should be planed properly and should be away from a-rea allotted for residential purposes.
- (iv) The area should be reduced to the maximum of 2 acres.

RESOLUTION: Noted. No Industrial concerns except the two already agreed viz. PWSR and M/S E.I. Industries should buallowed in the Cantonment area. The proposal of K.S.B. Pump Company Ltd be dropped. The President stated that the Governor of East Pakistan has agreed that industries should not be allowed to set in the Cantonment area.

14. DML&C's Signal No. 176-LC dated 19-1-61 was shown to the President, Cantonment Board.

RESOLUTION: The President saw the DML&C's Signal No. 176-LC dated 19-1-61 on the subject of M/S E.I. Industry and he ordered it to be added in the Board proceedings and that he did not agree with views of the Ministry of Defence and that he (GOC) will order cutting of water and electricity to the industry on the 15th February 1961. The President (GOC) further observed that the tenure of the Industry on the present site is far from legal, being only a temporary licence case.
