(b) The owners of the two restaurants in the Broadway Building should be advised to make fly proof arrangement for their restaurants immediately. They should be warned that their restaurants should be kept spotlessly cleaned otherwise the same would be closed.

Agenda No.13. To consider and approve list of applications for issuing Rickshaw owner Licence, list of application is put up.


Reso :- Considered and approved.


Agenda No.14. To discuss and consider the enhancement of Trade Licence fee.
